About Zenith

1. Zenith is a TEQSA approved Institute of Higher Education (PRV TBA) approved to deliver courses to overseas students in Australia studying on a student visa (CRICOS Code: TBA).
2. Zenith / the Institute delivers accredited courses in:
 - (a) Bachelor of Information Technology (Cybersecurity)
 - (b) Master of Business Administration (Cybersecurity Management)
3. All classes will be face to face, on campus in **Level 7, 451 Pitt Street, Sydney 2000 NSW**
4. Our key staff are:
 - (a) Zenith / the Institute CEO – Mr Vivian Lobo;
 - (b) Academic Dean – Prof Harvinder Singh
 - (c) Course Coordinator – TBC;
 - (d) Student Services Manager – TBC;
5. All contact details are in your Student Handbook.

Living and Studying in Sydney, Australia

Indicative Cost of Living

1. The Australian government estimates that it costs around \$21,000 per year, excluding tuition fees and insurance to live in Australia.
2. Students are encouraged to calculate their cost of living by going to the Australian government's website:

3. Your accommodation options include:
 - (a) privately managed student accommodations;
 - (b) private rental;
 - (c) homestay;

Visa Conditions

1. While you are studying in Australia on a student visa (sub-class 500), you must comply with certain rules and visa obligations.
2. Critical information will be presented during this orientation session, and all students are required to check the Department of Home Affairs website for the full conditions of your visa:
<https://immi.homeaffairs.gov.au/visas/already-have-a-visa/check-visa-details-and-conditions/see-your-visa-conditions?product=500#>.
3. You are allowed to work while on a student visa, but there is a limit on how much you work.
4. Remember you cannot work more than 40 hours per fortnight.
5. And don't forget you have rights while working in Australia. The Fair Work Ombudsman website will be helpful: <https://www.fairwork.gov.au/>.
6. Also while studying on a student visa:
 - (a) you have to remain enrolled in a CRICOS registered course as your visa is attached to the course CRICOS code;
 - (b) you have to attend and progress in your course. You are expected to complete your course within the expected duration stated on your Confirmation of Enrolment (**CoE**).
7. Zenith / the Institute provides a range of support programs to assist your progress towards course completion.
8. As a student visa holder, you must maintain Overseas Student Health Cover (**OSHC**) during your stay in Australia.
9. Insurance will help cover some of the cost of your visits to doctors and (depending on your level of cover) hospital treatment, ambulance and medicines.

11. You must comply with Australian laws, and avoid activities that threaten harm to others.
12. If you move while you are studying with us, you must always keep us informed of your residential address. If you move, advise Student Services in writing of your new address within 7 days of your move.
13. If you are bringing school-aged dependents with you, you will need to arrange for them to attend school and pay for their school fees.

Our Facilities and Resources

1. Student services and administration is located at: Level 7, 451 Pitt Street, Sydney 2000, NSW
2. Zenith's campus has 5 learning and teaching rooms, a library and student learning area, computer lab, private counselling room, student common room, an outdoor balcony, student administration area, vending machine, kitchen and access to quiet learning spaces.
3. All rooms are equipped with modern facilities to facilitate your learning.
4. There is an on campus library available to Zenith's students.
5. As a student you have free internet access. Connection is wireless throughout the campus.

Safety on Campus and Online

1. Zenith maintains a safe learning environment, on campus and online, for students, staff and visitors:
 - (a) clearly signposted entry and exit;
 - (b) security cameras positioned inside and just outside the campus but we will not breach your privacy.
2. Sexual assault and sexual harassment, including through emails or social media, is **NOT TOLERATED** at Zenith.
3. Penalties apply under our *Sexual Assault and Sexual Harassment Prevention Policy and Procedure*.
4. Sexual assault is a serious offence. If you see it happening to someone else, or you are the victim:

Contact police on 000 as soon as you can.

They are available 24 hours a day, 7 days a week.
5. Our *Sexual Assault and Sexual Harassment Prevention Policy and Procedure* explains how Zenith / the Institute deals with these types of incidents.
6. Diversity and equity is embraced at Zenith.
7. Zenith also does not tolerate discrimination, bullying or victimisation.
8. If you see a fellow student being discriminated against, bullied or victimised, or if you are experiencing it yourself, please contact Student Services.
9. Our *Student Equity and Diversity Policy and Procedure* describes:
 - (a) how we create an environment that is inclusive and welcoming;
 - (b) what happens when these incidences are reported.
10. Online safety is also important at Zenith.
11. As a Zenith student, you have access to our IT systems and resources, including:
 - (a) up to date software and anti-virus software installed on our devices;
 - (b) firewall set up to protect software and hardware;
 - (c) access to free Wi-Fi.

In making this available, you should:

 - limit use for personal reasons;
 - not damage or interfere with our IT systems and resources. If they are not working, report this to Student Services. Do not try to fix it yourself;
 - be respectful and protect your privacy and those of others;
 - not share your login details and password. Zenith uses multi-factor authentication to login to your Zenith email.
 - not download, upload or publish illegal content, including illegally sourced software or content.

What Support Services are Available

1. Support (personal or academic) can be one-on-one including confidential consultations.
2. Formal English language proficiency workshops or classes.
3. Counselling services from Associated Counsellors & Psychologists [subject to TEQSA registration]. The Student Services Manager can organise this for you, but keep in mind that there may be a charge for this service.
4. Information technology support if you have trouble connecting with our Wi-Fi or LMS.
5. Formal training is provided to ensure understanding and familiarity with the use of the LMS.
6. Technical assistance is available by contacting IT Manager on [**insert phone number**].

Academic Integrity

1. Students are encouraged to be honest in preparing their assignment and sitting their exams.
2. When using the work of others in your assignment, properly referencing or attributing their work.
3. When you are in an exam, listen to the invigilator and follow the rules.
4. A breach of academic integrity is academic misconduct.
5. Common examples of academic misconduct include:
 - (a) cheating – dishonest, fraudulent or deceitful conduct;
 - (b) contract cheating – paying someone else or a company to provide content for assessment;
 - (c) plagiarism – using the work or ideas of someone else without appropriately acknowledging their work;
 - (d) communicating with other students during an exam
 - (e) attempting to read the work of another student during an exam.
6. If, after investigation, you are found to have breached academic integrity rules at Zenith / the Institute, you may:
 - (a) be referred to learning support staff for more education about academic integrity;
 - (b) have the opportunity to redo and resubmit your assessment with a penalty applied;
 - (c) receive a warning.
7. If you are found to have committed major academic misconduct, you may:
 - (a) receive a Fail grade; or
 - (b) suspended or excluded from your studies.

The *Student Academic Integrity Policy and Procedure* has more details, including how to appeal a finding of academic misconduct.

8. The Zenith Innovation Institute Artificial Intelligence Framework (AI Framework) proactively ensures the quality of course delivery amidst AI's growing impact on education. This Framework supports corporate and academic governance, risk management, policy development, and ongoing enhancements in areas influenced by AI. ZII aligns this framework with the Tertiary Education Quality and Standards Agency's (TEQSA) principles to safeguard student interests and uphold the standards of Australian higher education.

Academic Freedom

1. The right to academic freedom is central to teaching, learning and scholarship.
2. Therefore, Zenith / the Institute is committed to upholding and protecting freedom of academic expression. This means:
